NOTE TO SCHOOL OFFICIALS

National Federation Track and Field Rule 7-5-3. The competitor's weight shall be at or below the manufacturer's pole rating. The manufacturers must include on each pole: the pole rating that shall be a minimum of 3/4 inch in a contrasting color located within or above the top handhold position; a 1-inch circular band indicating the maximum top handhold position with the position being determined by the manufacturer.

Note: Older vaulting poles should be marked with the manufacturer's pole rating by use of an indelible marking pen in a one-inch contrasting color printed lengthwise above the handhold band.

MPA meet directors reserve the right, at state meets, to use this form to compare the manufacturer's pole rating and the weight of each vaulter.

Pole Vaulting Consent, Waiver and Helmet Rule

Consent to Participate and Waiver of Liability – Pole Vaulting

I hereby grant permission for myself/child, _____, to participate in the interscholastic sport of pole vaulting. I verify that myself/child has had a physical exam within the past two years and is capable of participating in all activities related to pole vaulting. I understand that track and field in general, and in particular pole vaulting, are potentially dangerous activities that pose a risk of serious injury and death to participants. I agree to indemnify, hold harmless, and defend, my child's school, the Maine Principals' Association and the National Federation of High Schools, their agents, employees and sponsors from any and all liability for injury to my child, as well as any damage or injury caused in whole or in part by my child. Should medical attention be necessary, I hereby authorize any physician or trainer selected by team personnel to conduct medical or surgical procedures.

Mandatory Helmet Rule

The efficacy of the use of helmets in pole vaulting is currently being studied and evaluated. Although there is no compelling scientific evidence that the use of a helmet will prevent serious injury in the event of a landing outside the pit from the top of the vault, common sense tell us that helmets will mitigate head injuries in at least some circumstances. Therefore, in addition to imposing tighter safety standards on landing pits and vaulting poles, helmets have been mandated in all MPA sponsored events and the MPA strongly urges all member schools to mandate the use of helmets in all practices and regular season meets. Accordingly, _____ High School has adopted the these recommendations and requires the use of a helmet for pole vaulting during all practices, exhibitions and interscholastic meets. Currently there is not a helmet which meets the new ASTM-(F2400-06). Suggested helmets include the KDMAX helmet or a NOCSAE approved lacrosse helmet without face guard or visor. The helmet should never be a substitute for safe equipment or sound techniques.
